Background

The World Health Organisation (WHO) estimates that 10.5 million children die annually from preventable diseases (UN, 2006) the majority of these deaths occur in developing countries, particularly in Africa. Uganda's Gross National Income per capita is; (PPP International \$) \$880.

In Uganda I in 13 newborns die in their first year of life while I in every 7 children die before their 5th birthday. Seventy percent of all childhood mortality in Uganda is due to Malaria, Acute Respiratory Tract Infection, Diarrhoea or Malnutrition (Uganda MOH, 2005). A large proportion of the childhood death occurs at home due to lack of access (both physical and/or financial) to health facilities. Within healthcare facilities healthcare workers are only expected to provide health care, the cleanliness and feeding of children is the responsibility of family members and caregivers. Until the opening of Holy Innocents Children's Hospital, there were no dedicated children's facilities in Uganda. In fact the Mbarara Regional referral hospital serving Southwestern Uganda, a population of about 6 million people of whom 15% are aged under-five, has a 60 bed pediatric unit with a bed occupancy rate of 100 - 120%.

Holy Innocents Children's Hospital

The Holy Innocents Children's Hospital (HICH) is a project first conceived in 1989 by the Catholic Archdiocese of Mbarara and brought to fruition by a partnership between the Archdiocese and a group of faith partners in San Diego, California (USA). HICH is dedicated to providing the children of the Mbarara region with superior and specialized paediatric health care. It is a purpose built facility with 60 inpatient cots/beds and an urgent care/review outpatient department which opened on 4th July 2009.

The mission is to develop a regional referral hospital at Nyamitanga specializing in paediatric care for children from birth to age twelve that functions on the ethics and principles of the Catholic church, collaborates with the national strategic health plan as well as national/international partners and community outreaches.

Accountability

Holy Innocents Children's Hospital Inc., in San Diego, California (USA) (HICH San Diego) is a Charitable Trust (U.S. IRS 501 (c)(3) non-profit) which entered into a memorandum of understanding with the Mbarara Archdiocese, Uganda to begin this project. The HICH San Diego Board of Directors provides oversight for funding raised in the United States (US), paediatric specialization training as well as utilisation of funds at the hospital.

Additional oversight within Uganda is provided by a Ugandan Board of Governors who have been appointed by the Archbishop of the Mbarara Diocese. They are responsible for fundraising/collaboration within Uganda as well as utilisation of funds at the hospital.

A Northern Ireland Chapter has been established for fundraising and collaboration efforts and works in collaboration with both Boards. This Chapter became a UK registered charity in April 2010. XT24667

Successes

 Rapid adoption by the families in the community and surrounding communities, seeking care for their children. A total of 15,177 outpatients and 3,472 inpatients for the fiscal year ending June 30, 2010.

- Even though HICH has seen numerous critically ill children the mortality rate for this first year of operations has been less than 1%.
- Nurse/Patient ratios higher than in most Ugandan hospitals.
- Each child has his/her own bed.
- Modest fees which include pharmaceuticals. All services are included in basic charges.
- Passage of facilities inspection by the Ministry of Health in November 2009 for licensure as a Uganda Health Centre.
- Successful service expansion in response to the January malaria epidemic in the Mbarara region. This included the rapid opening of a third ward, which had not yet been scheduled to open.
- Clean and modern facility with strong emphasis on infection prevention and control.
- Clinical and Nursing staff focused on paediatric care Supervised by Professors of Paediatrics.
- Additional services initiated such as HIV counseling and immunizations.
- Favorable financial audit and controls review of the hospital operations.
- Opening of an onsite canteen for the convenience of patients, care givers and staff.
- Improvements to staff housing.
- Continued beautification of buildings and grounds.
- Sponsored two community football tournaments.
- Multiple volunteers from Northern Ireland, USA, Canada and the Czech Republic.
- Donations from UK, USA, ROI and within Uganda.







Challenges

- Funding, and therefore self sustainability, is difficult due to the in come level of many families served making cash or in kind donations of drugs and medical supplies absolutely required.
- Supplying and provisioning of the hospital is difficult due to the distance from suppliers in Kampala.
- Donated supplies and pharmaceuticals are not always suitable to paediatric care or the specific services provided at HICH.
- Drainage of the hospital campus is problematic and results in standing water malaria hazard. Assistance from a civil engineer and a grading contractor is needed.
- Shortages of critical supplies and equipment due to "out of stocks" are frequent.
- The hospital is in need of a blood refrigerator in order to maintain an in house blood supply. Currently each unit of blood must be procured from the local blood bank, one at a time.
- Electrical supplies through UMEME are expensive with frequent outages. Back up power is problematic due to an inadequate generator.
- There is no supplier of medical oxygen in Mbarara. The closest supplier is in Kampala (4.5 hour drive one way drive).
- An ambulance for transporting children is required.

Summary of Patient Services for Fiscal Year 2009 – 2010

To date the hospital has serviced a total of 15,177 outpatients and 3,472 inpatients with ages ranging from newborn to 12 years of age. HICH is very proud that the mortality rate of all children presented at the hospital is less than 1% percent. This is a testament to the quality standard of care provided by HICH.

As HICH provides both Outpatient and Inpatient services, the following section provides more specific details regarding each of these activities:

Outpatient

Outpatient visits saw a steady increase through to March. However a decrease occurred during the 4th Quarter, which appears to coincide with a patient fee increase which was effective March 15th 2010.

Inpatient



Initially, two of three wards were opened in the 1st quarter of the fiscal year 2009. The third ward was opened upon urgent necessity in December 2009 when the influx of patients spiked rapidly due to a malarial outbreak. During lower hospital census the third ward is shuttered with the ability to reopen as needed. Additionally a Special Care Unit (SCU) has been created and tracked separately since February 2010.

Throughout this entire first year of operations the Inpatient top diagnoses have been: I. Malaria 2. Pneumonia 3. Anemia 4. Dehydration

Additional Services

Throughout this inception year the hospital has offered or partnered with organizations to provide the following additional services:

- HIV Testing and Counseling HIV Testing and Counseling began in June 2010 and a total of 22 individuals have received testing and counseling.
- Immunization Services Immunization programs commenced in mid-March 2010. Since that time a total of 1202 immunizations have been given.
- Additionally, a public service radio announcement was made for use on Radio Maria, the local radio network and written information was created for dissemination in area.
- Tuberculosis Services Services such as testing, education, treatment and surveillance began in mid-June 2010. A total of I Client is currently under surveillance and treatment
- Case Management Discharge planning and continuity of care was provided from December 2009 to April 2010 by a volunteer from the United States Peace Corps.
- Community Education and Outreach Includes nutrition classes as well as education regarding the risks of "miletting" (folk medicine practice involving ritual cutting of children). Additionally, a Peace Corps worker had been assigned to assist HICH with community outreach for six months of the year. During which time she instituted; a schools program teaching health education, nutrition and American culture, established, in cooperation with a local partner agency Organized Useful Rehabilitation Services (O.U.R.S), a support group for parents of children with Cerebral Palsy.
- Mosquito Nets The hospital opened with a stock of donated mosquito nets. These nets were distributed to the families of in patients upon discharge. This service was indefinitely suspended in October 2009 when the stock ran low.
- Canteen In March 2010 a canteen on the property was opened. The canteen has goods and meals available for purchase by hospital staff as well as patient's families.







Staffing & Staff Training

HICH is fortunate to have been able to recruit Ugandan National nurses and doctors to provide full time care for patients. The hospital is operated utilising Ugandan workers, except for the Hospital Administrator, Peace Corps Worker and several volunteer delegations (consisting of nurses, doctors and other skilled professionals).

During the year, two groups of nursing and medical staff visited from the US, led by Professor Anita Hunter from the University of San Diego, California. Visiting nursing staff provide the opportunity for knowledge exchange, special training sessions as well as first hand review of patient care procedures at the hospital.

While many of the nurses at HICH are recent graduates they are being further trained in appropriate and effective care of paediatric patients. All nurses have personal professional development portfolios. Since openening In-service and Continuing Medical Education is provided by both internal staff and external facilitators on a regular basis to ensure continued professional growth and to emphasise specific skills needed in the daily care of paediatric patients.

Sample topics have included, but are not limited to:

- HIV/AIDS Testing and Counseling
- Gastro-enteritis
- Pneumonia and Oxygen Therapy
- Swine Flu
- Infection Prevention and Control
- Neonatal Sepsis
- Obtaining Laboratory Specimens

- Nutritional Assessment
- Spina Bifida
- Hydrocephalus
- Chest Physiotherapy

Equipment

Much of the equipment has been donated from the United States and Northern Ireland. Along with many individual donations, major donations were supplied by the Rotary Club Fallbrook California, Belfast Health and Social Care Trust, Belfast City Council and Sabin Children's Foundation.

A source of frustration for the Hospital Administration as well as the Board members is the amount of donated equipment which is only suitable for adult use or for services which are not provided by HICH at this time. To ensure the unusable donated items were not wasted HICH found other organizations in the Mbarara area that would utilise this equipment (included but not limited to):

- University Hospital Mbarara
- Eye Hospital Mbarara
- Ibanda Hospital
- Ibanda Babies Home
- Archdiosese Health Centers
- Comboni Hospital
- Wisdom Center for the Disabled

Buildings/Facilities

The Hospital buildings were recently constructed by Block Technical Services Mbarara and completed in June 2009. Total new construction included:

- Administration and Outpatient complex ; providing for Pharmacy, Medical Records, Clinical Rooms, Accounting, Laboratory and X-Ray (opening on hold)
- Three patient wards with capacity for up to 20 beds each (for a total of 60 beds)
- Special Care area
- Staff changing and rest area
- Mortuary

The ward and administration structures have covered walkways in order for patients and their families to shelter from the elements. Also, in order to reduce the incidence of pests in the wards, screens for windows and doors were installed along with electronic pest control.

Hot water is also provided for showering and cleaning. Networking of the outpatient and administration areas was completed by Mr. Tommy Brett [Ireland]

Additionally, many staff members are provided with housing as an employment benefit. An older building on the property has just been remodeled and turned into housing units for the staff this was accomplished through donations from the Beirne Family, Leeds, England.

Once phase one construction was completed vegetation has begun to grow and landscaping of the hospital and staff grounds has occurred. All plants have been donated or transplanted. Not only does this serve to beautify, it also helps to alleviate standing water and therefore reduce the mosquito population.

Governance

In order to accomplish the governance goals and Management Objectives a performance monitoring report has been developed. This report is presented to the local board on a monthly basis and copies sent to the San Diego Board and to the Northern Ireland Chapter. An annual management plan was developed which is updated quarterly and presented to the boards. Several meetings have been instituted:

- Bi-weekly meetings with all staff (these were weekly during the first 5 months of operations)
- Clinicians hold daily and weekly patient review meetings
- Monthly meetings for nursing and support staff
- Monthly Ugandan Board meetings

To address important topics collaboratively and cross functionally, several hospital committees have been formed:

- Infection Prevention and Control Committee Established 21 September 2009 to develop guidelines and make recommendations. Chairperson Kenyangi Winnie Edreda
- Immunization Committee Established in February 2010 to write protocols and supervise the immunization services

The hospital became licensed as a Uganda Health Center upon passing facilities inspection by the Ministry of Health in November 2009 and subsequently has received the formal Certificate of Registration for calendar year 2010 from the Ministry of Health Offices in Kampala. In February 2010 the hospital received a supervisory visit from the Mbarara Municipality Health Authority with no significant deficiencies noted. The certification with the Uganda Catholic Medical Bureau has been ongoing and is scheduled to be completed by the end of 2010







Risk Assessment & Audit/Controls Review

An organisational risk assessment was completed and has been regularly reviewed. Findings are prioritized and reported on a monthly basis. High risk areas are actioned, prioritized and completed as funding is available. A baseline hospital hygiene audit was completed in August 2009. Recommendations were made and actioned with regular repeat audits.

In January HICH received a favorable, onsite review of local financial, cash controls and operating procedures. The final report and recommendations were submitted to the HICH San Diego Board.

Financials

As the Annual Financial Report details, the total cost of operating the hospital in the first year was 625,416,410 Ugsh and revenues totaling 631,510,481 Ugsh were received. Over ninety percent of operating revenues come from two sources; was after 63% contributed by HICH San Diego (400,400,367 UGSH) and 30% from patient fees.

While patients are expected to pay for services rendered HICH recognizes that there are patients who are unable to pay their bills in full. HICH does not prescreen patients for ability to pay, nor are patients turned away if they are unable to pay. Therefore, a Charity Care fund was established in August 2009 by Mr.Terry Turkington [N.I] this fund has continued to be supported with donations from Northern Ireland in order to cover the shortfall in funds for those unable to pay. To date a total of 3,631,300 Ugandan shillings, or less than 2% of patient fees, were provided to 238 patients who have been unable to pay their bills in full.

In addition to revenue from patient fees, the Charity Care fund and HICH San Diego, other sources of income were 3.5% from Other Donations and Grants and 2% from the Mbarara Arch Diocese.

The actual revenue amounts were approximately 94% of the forecast amount and actual expense amounts were approximately 96% of the forecast amount. This is quite remarkable considering there were no benchmark's available (no children's hospital in Mbarara much less Uganda) nor were detailed studies performed of ability to pay or amount of need in the area.

The Top four expense categories, representing over 87% of operating expenses, are as follows:

- I. Salaries, Income Tax & National Social Security Fund 55%
- 2. Medical Drugs, Sundries and Lab Supplies 20%

3. Equipment – 6%

- 4. Utilities 5%
- *These numbers do not reflect donated supplies and equipment

Of note, salaries alone expend more than the income received from patient fees.

The totals on the Financial Report, included as an addendum at the end of this report, include additional funds raised for capital expenditures in the revenue section and include expenditures for capital assets acquired or built with the capital funds. e.g. housing, drainage system, furniture, and construction costs.

At the date of this report currency rates are 2200 UGX/IUSD & 3400UGX/IGBP
